## **Public Participation:**

It is the policy of the Approval Authority to encourage and permit public participation and comment on matters within the Approval Authority's jurisdiction, as follows.

- Public Comment on Agenda Items. The Approval Authority will take public comment on each item on the agenda. The Approval Authority will take public comment on an action item before the Approval Authority takes any action on that item. Persons addressing the Approval Authority on an agenda item shall confine their remarks to that particular agenda item. For each agenda item, each member of the public may address the Approval Authority once, for up to three minutes. The Chair may limit the public comment on an agenda item to less than three minutes per speaker, based on the nature of the agenda item, the number of anticipated speakers for that item, and the number and anticipated duration of other agenda items.
- General Public Comment. The Approval Authority shall include general public comment as an agenda item at each meeting of the Approval Authority. During general public comment, each member of the public may address the Approval Authority on matters within the Approval Authority's jurisdiction. Issues discussed during general public comment must not appear elsewhere on the agenda for that meeting. Each member of the public may address the Approval Authority once during general public comment, for up to three minutes. The Chair may limit the total general public comment to 30 minutes and may limit the time allocated to each speaker depending on the number of speakers during general public comment and the number and anticipated duration of agenda items.

- *Speaker Identification*. Individuals making public comment may be requested, but not required, to identify themselves and whom they represent.
- Designated Public Comment Area. Members of the public wishing to address the Approval Authority must speak from the public comment area.
- Comment, Not Debate. During public comment, speakers shall address their remarks to the Approval Authority as a whole and not to individual Approval Authority representatives, the General Manager or Management Team members, or the audience. Approval Authority Representatives and other persons are not required to respond to questions from a speaker. Approval Authority Representatives shall not enter into debate or discussion with speakers during public comment, although Approval Authority Representatives may question speakers to obtain clarification. Approval Authority Representatives may ask the General Manager to investigate an issue raised during public comment and later report to the Approval Authority. The lack of a response by the Approval Authority to public comment does not necessarily constitute agreement with or support of comments made during public comment.
- Speaker Conduct. The Approval Authority will not tolerate disruptive conduct by individuals making public comment. Speakers who use profanity or engage in yelling, screaming, or other disruptive behavior will be directed to cease that conduct and may be asked to leave the meeting room.

## REGULAR MEETING MINUTES DRAFT

## 1. ROLL CALL

Approval Authority Vice Chair Richard Lucia called the meeting to order at 10:00 AM and General Manager Craig Dziedzic subsequently took the roll. Chair Mary Ellen Carroll was absent with no alternate. Vice-Chair Lucia was present. Members Michael Cochrane, Jessica Feil, Dana Reed, Raymond Riordan, and Gerry Malais were present. Members Mike Casten, Bob Doyle, and Mark Robbins were absent, but their alternates, Thomas Chalk, Rick Navarro, and Scott Kirkpatrick were present. Member Godley arrived at 10:27 AM.

## 2. APPROVAL OF THE MINUTES

#### 3. GENERAL MANAGER'S REPORT

#### a. FY20 UASI Grant Update

General Manager Craig Dziedzic notified the Approval Authority that on April 10, 2019, the Department of Homeland Security (DHS) issued Information Bulletin 447, which modified the FY 2020 Notice of Funding Opportunity (NOFO) by announcing final UASI awards. Mr. Dziedzic stated that under IB 447, the Bay Area UASI received a final award of \$37.5 million, which is \$10 million more than last year. The NOFO required the funding of four National Priority Projects addressing the areas of Cybersecurity, Soft Targets, Intelligence/information

Sharing, and Emerging Threats) – each project to be funded at least 5% of the total allocation for a total of 20%. Mr. Dziedzic stated that Cal OES would again use 17.3% as the retention percentage- the same percentage as last year. Therefore, the net balance of the Bay Area's award is \$31,012,500, which is \$7,840,000 more than last year.

## **Discussion/Description:**

## (a) Regional Grants Update

FY 2019 and 2020 San Francisco Bay Area Securing the Cities (STC) Grant Program

In FY 2019, the Countering Weapons of Mass Destruction (CWMD) Office awarded the San Francisco Bay Area Region \$2 million for Phase 1 (Engagement) of the STC grant program – a cooperative grant with a 10-year performance period. The Bay Area STC geographical region includes not only the UASI footprint, but also the CA counties of Sacramento and Fresno as well as Washoe County, NV. Phase I milestones included establishing a program management office, governance structure (workgroup and subcommittees), and executed Principal Partners' Charter and Implementation Plan. These milestones will be discussed later as a separate agenda item.

The UASI General Manager and Regional Program Manager are currently overseeing the milestones of the grant program. The San Francisco Board of Supervisors approved the Accept and Expend legislation, which included the approval of four (4) FTE positions for the grant management office. The Management Team has hired SenseMakers, LLC as a consultant to assist in advising and completing the various grant milestones.

The CWMD Office recently announced that the Bay Area region was eligible to apply for year 2 (FY 2020) of grant funding, which focuses on Phase II (Implementation) to enhance initial operational capabilities to detect/report the presence of radiological/nuclear materials out of

regulatory control. Phase two is expected to take three years and its milestones include development of operations/deployment plans, procurement/deployment of equipment, and training/exercise. The Bay Area Management Team will be submitting an application before the September 8<sup>th</sup> deadline in the amount of \$3 million (\$1 million more than what was expected).

## (b) FY 2020 Regional Catastrophic Preparedness Grant Program (RCPGP)

On August 15, 2020, FEMA announced that the Bay Area UASI was one of 12 jurisdictions to be awarded funding for the FY 2020 RCPGP. The Bay Area UASI will receive \$929,414 – the highest amount to be awarded. Our initiative will focus on regional pandemic preparedness- an objective that FEMA added this year, with a specific emphasis on addressing the Community Lifelines and Core Capabilities that are essential to pandemic preparedness.

## (c) FY 2021 UASI

On September 17<sup>th</sup>, the Management Team will present the FY 2021 UASI project proposal process via virtual meetings among the region's stakeholders. The grant portal will be open on September 18, 2020 and closed on October 9, 2020.

## (b) Management Team Update

I am pleased to announce the appointment of Jodi Traversaro as our new Training and Exercise Program Manager who will be teaming with Corrine Bartshire to oversee not only the regional training and exercise program, but also RCPGP initiatives. Jodi previously worked at BART leading preparedness, mitigation, and emergency response operations across multiple business lines and jurisdictions.

Prior to her role at BART, Jodi served as the Coastal Region Administrator for Cal OES, where she led a team supporting local and regional response and recovery efforts for multiple earthquakes, fires and floods. Her experience also included oversight of the California Specialized Training Institute (CSTI), implementing NIMS statewide, developing occupational certificate programs, and implementing ICS position-specific credentialing programs.

Jodi grew up in the Bay Area, earned a BS in Economics from Cal Poly, San Luis Obispo, and has been a Certified Emergency Manager for over a decade. Jodi was the recipient of the 2018 Public Safety Hero of the Year Award by Congressman Mike Thompson and was recognized on the Senate Floor by Senator Mike McGuire for her leadership and support of local government during the North Bay Fires.

## **Background:**

The Bay Area UASI Chemical Biological Radiological Nuclear Explosive (CBRNE) Program coordinates initiatives and oversees regional projects in the following CBRNE goal areas:

- Enhancing the Protection of Soft Targets
- Addressing Emergent Threats
- Protecting Critical Infrastructure and Key Resources

The CBRNE Work Group is composed of regional subject matter experts who are Fire, HazMat, Law and Maritime first responders. The CBRNE Work Group meets quarterly to support the goals/mission of the Bay Area UASI.

In 2014, the CBRNE Work Group established a Preventative Radiological Nuclear Detection (PRND) Focus Group to establish baseline capabilities and operational requirements for detecting and interdicting radiological/nuclear threats. Subsequently, the PRND focus Group's mission merged into the goals of the CBRNE working group, and consequently align with STC program.

## **Background:**

On March 4<sup>th</sup>, the Countering Weapons of Mass Destruction (CWMD) office, the agency overseeing the Securing the Cities (STC) grant program notified the Bay Area UASI of its selection for the program, which is a prescriptive grant with a 10 year performance period. The goals of the grant are to reduce the risk of a successful deployment of a radiological nuclear weapon in a large geographical area, and to achieve a unified approach that leverages federal, state, and local assets.

The Bay Area UASI was awarded a \$2 million dollar grant for the first year to build out an organizational structure that covers the Bay Area UASI footprint, including Fresno and Sacramento Counties, as well as Washoe County, Nevada. Each year grant recipients must submit an application for further funding.

## **Discussion:**

Today an update on the Securing the Cities San Francisco Bay Area (STC SFBA) program activities will be provided. Chris Bausch from SenseMakers LLC will present an overview of STC SFBA progress and plans (Appendix A). Thea Philliou, Senior Scientist from the Office of Countering Weapons of Mass Destruction, will present on the CWMD STC program information sharing tools available to the STC SFBA agencies (Appendix B).





# **National Prevention Framework**



The National Prevention Framework describes what the whole community—from community members to senior leaders in government—should do upon the discovery of an imminent threat to the homeland. An imminent threat is intelligence or operational information that warns of a credible, specific, and impending terrorist threat or ongoing attack against the United States. This Framework helps achieve the National Preparedness Goal of a secure and resilient Nation that is optimally prepared to prevent an imminent terrorist attack within the United States.

**Prevention:** The capabilities necessary to avoid, prevent, or stop a threatened or actual act of terrorism. Within the context of national preparedness, the term "prevention" refers to preventing imminent threats.

**Protection:** The capabilities necessary to secure the homeland against acts of terrorism and manmade or natural disasters.

**Mitigation:** The capabilities necessary to reduce loss of life and property by lessening the impact of disasters.

**Response:** The capabilities necessary to save lives, protect property and the environment, and meet basic human needs after an incident has occurred.

**Recovery:** The capabilities necessary to assist communities affected by an incident to recover effectively.

# **National Prevention Framework Guidance**

This Framework provides guidance to individuals and communities, the private and nonprofit sectors, faith-based organizations, and all levels of government (local, regional/metropolitan, state, tribal, territorial, and Federal) to prevent, avoid, or stop a threatened or actual act of terrorism by:

- Describing the core capabilities needed to prevent an imminent act of terrorism;
- Aligning key roles and responsibilities to deliver Prevention capabilities in time-sensitive situations;
- Describing coordinating structures that enable all stakeholders to work together; and
- Laying the foundation for further operational coordination and planning that will synchronize Prevention efforts within the whole community and across the Protection, Mitigation, Response, and Recovery mission areas.

# **Guiding Principles of Prevention**

- The desired end-state of the Prevention mission area is a Nation optimally prepared to prevent an imminent terrorist attack within the United States. To achieve this end-state, this Framework sets out three principles that guide the development and execution of the core capabilities for Prevention:
  - (1) Engaged Partnerships;
  - (2) Scalability, Flexibility, and Adaptability; and
  - (3) Readiness to Act.

# STC Mission Statement
