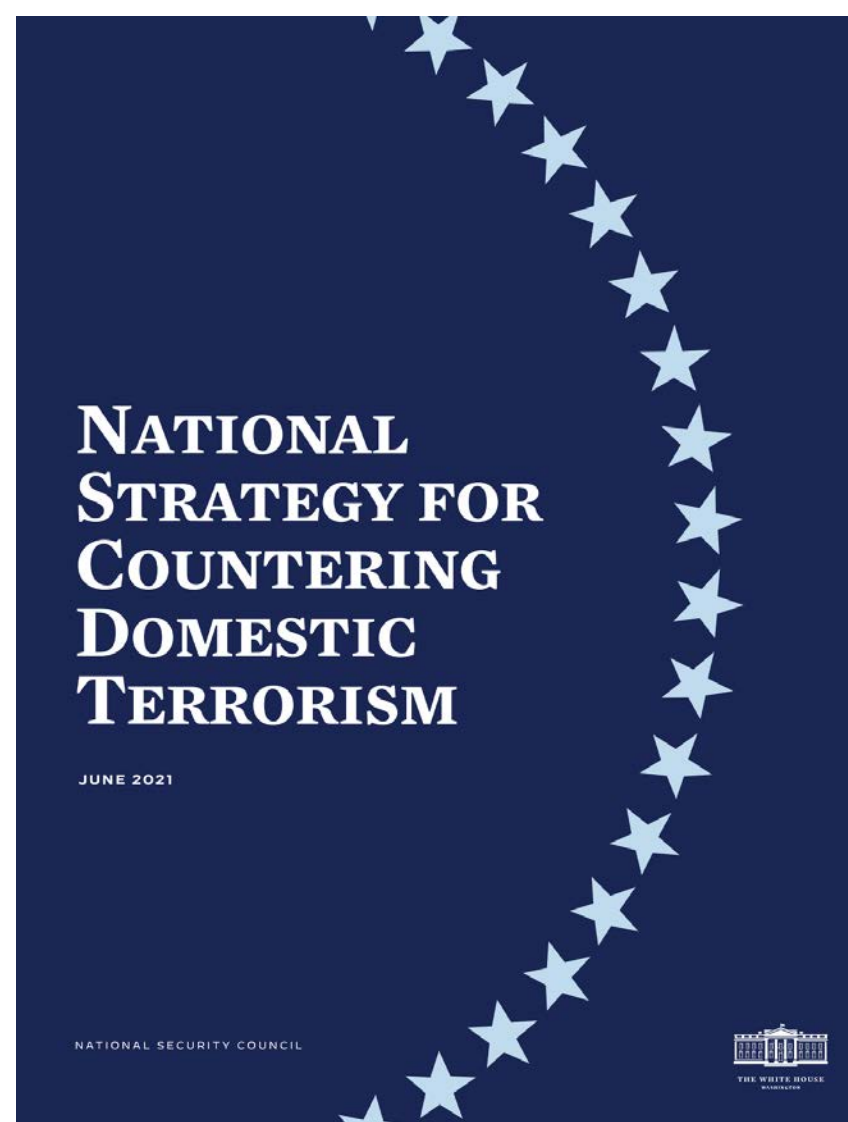

March 2021

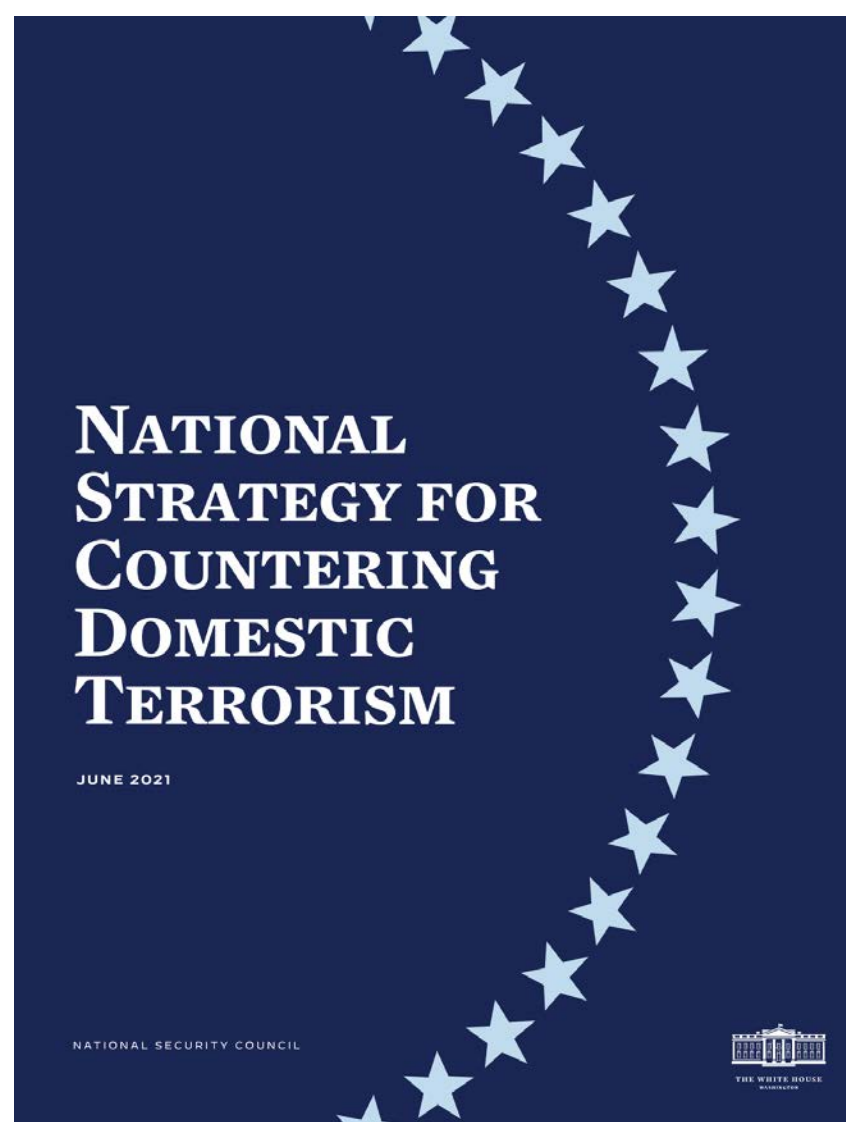
- The Intelligence Community (IC) assessed Domestic Violent Extremists (DVEs)
- Motivation: a range of ideologies, galvanized by recent events in the US
- Pose an elevated threat to the Homeland in 2021.

Federal law defines “domestic terrorism” as:

- “...Involves acts dangerous to human life... a violation of the criminal laws of the US or any State;
- Intended to intimidate or coerce a civilian population,
- Influence the policy of the government by intimidation or coercion, or
- Affect the conduct of a government; and occurs primarily within the territorial jurisdiction of the United States.”

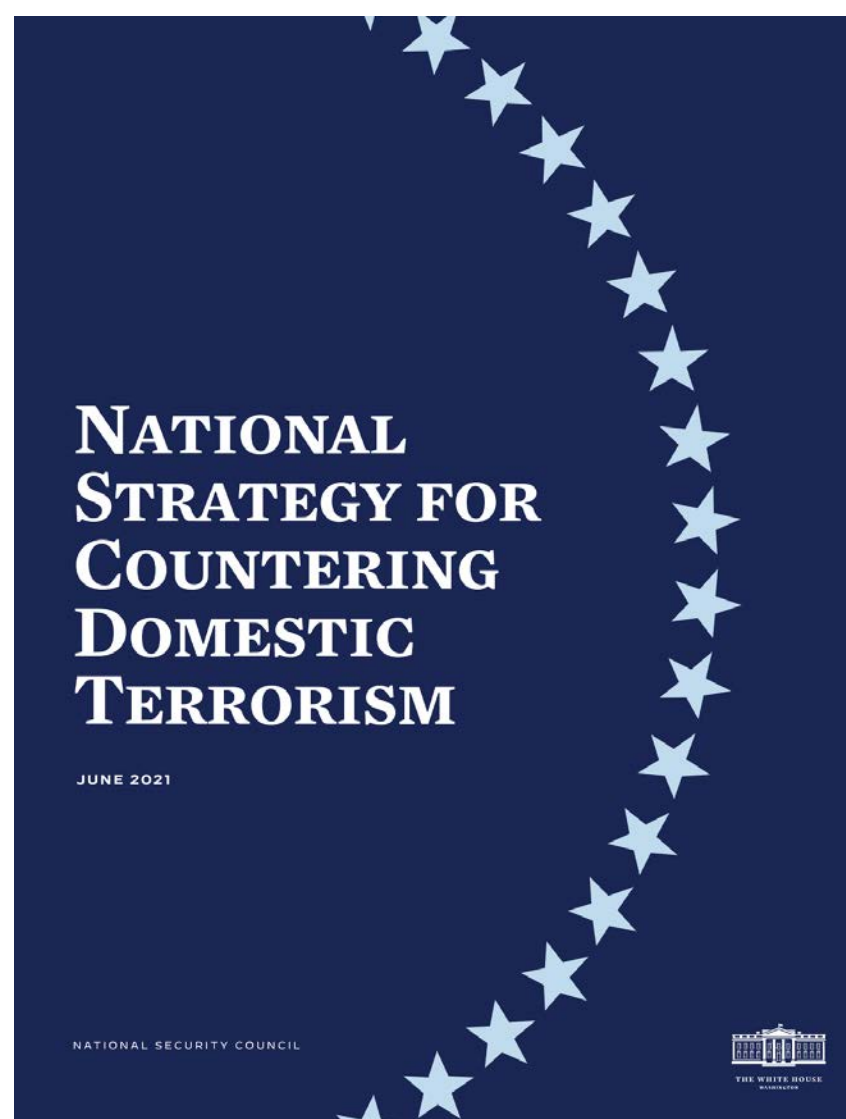

Today's domestic terrorism threat

- Racially or ethnically motivated
- Violent extremists & networks
- Racial, ethnic, or religious hatred leads them toward violence...



Key threat components

- Anti–government or anti–authority violent extremists
- Includes self–proclaimed “militias” and militia violent extremists
 - Take steps to violently resist government authority
 - And/or facilitate its overthrow.

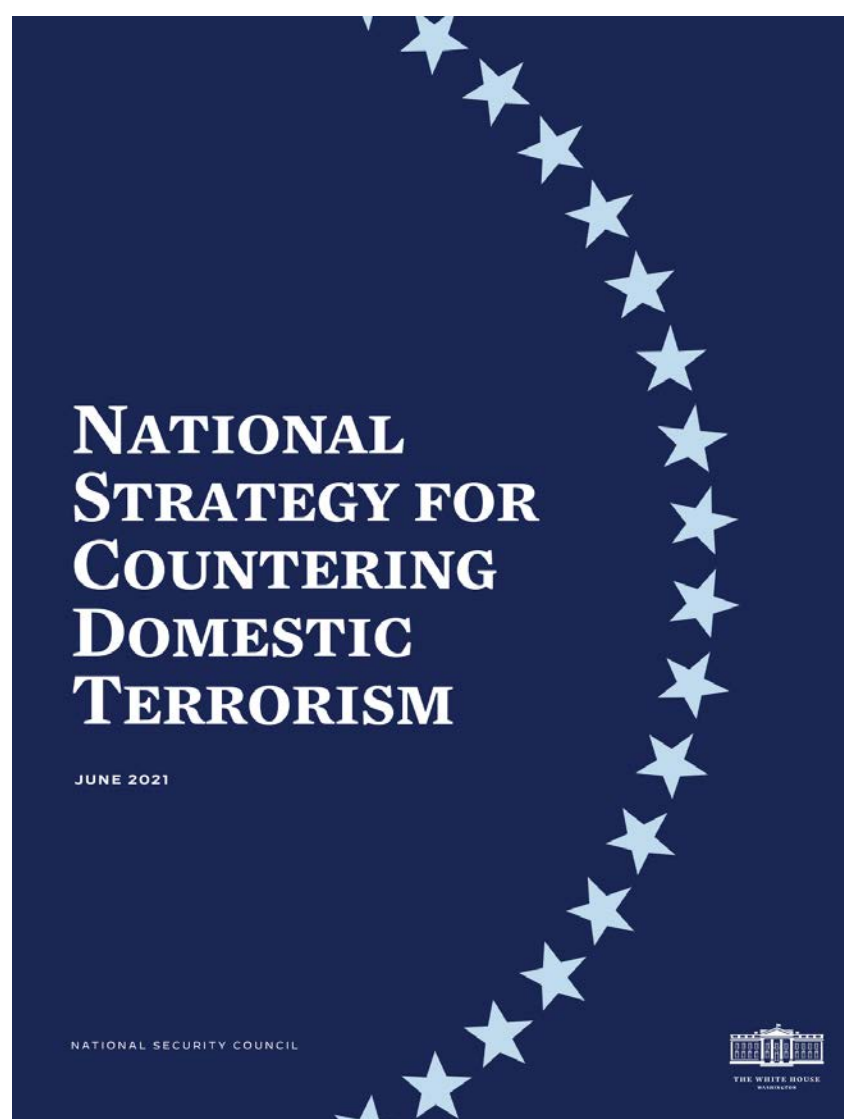

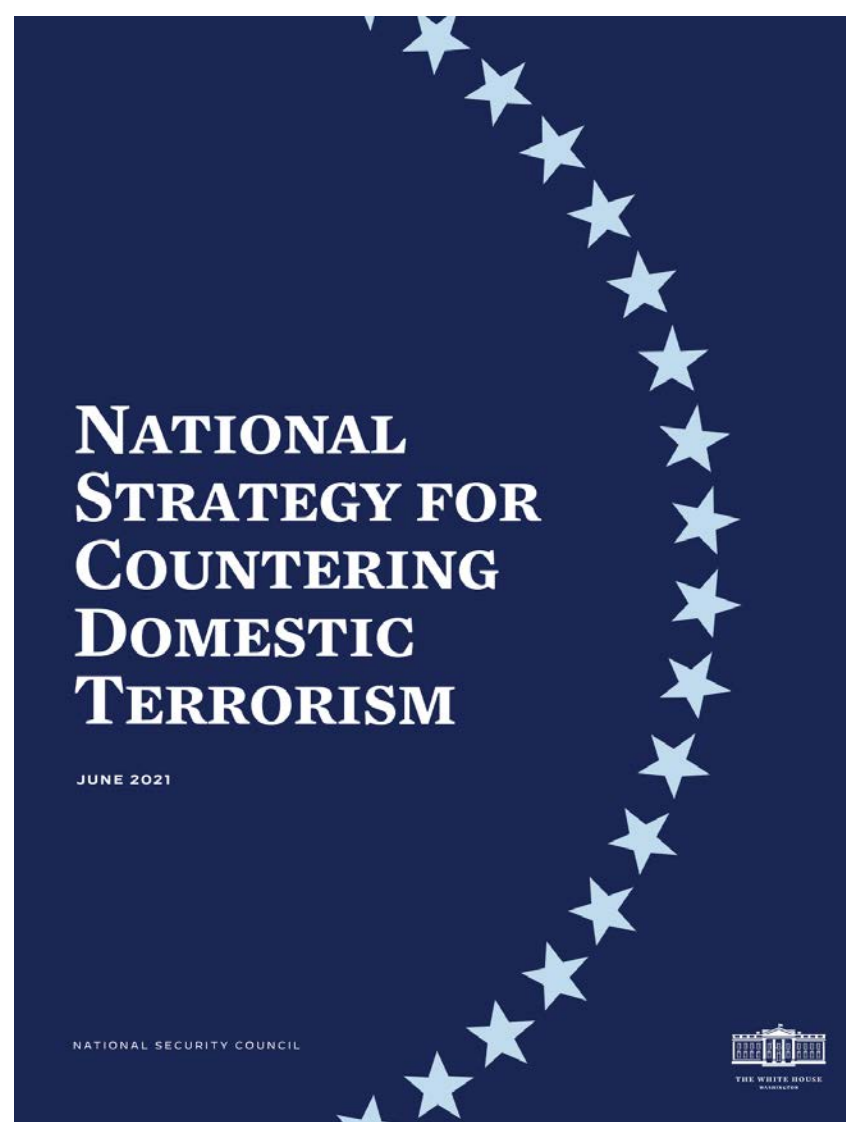


Strategic Goal 3.1:

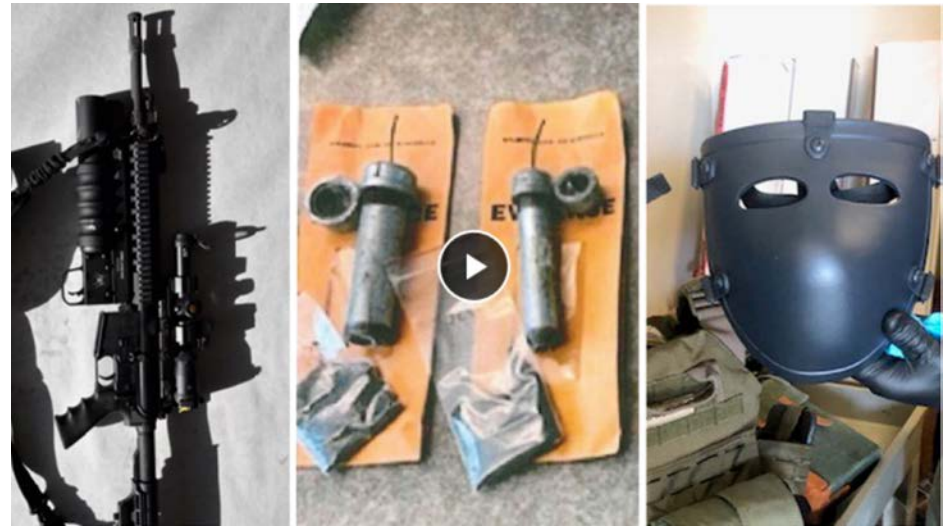
