### **Securing The Cities**

The San Francisco Bay Area Securing the Cities (SFBA STC) Program recently sent representatives to Los Angeles to participate in that City's Full-Scale Exercise, "Operation Lighthouse." This opportunity allowed SFBA STC staff to share our experiences with hardening targets and preventing terrorist attacks at major sporting venues with our LA STC counterparts. The lessons learned in LA will be leveraged during our prioritization meetings as we

prepare for the SFBA STC Full Scale Exercise. In addition, the STC program has recently taken delivery of our first shipment of Personal Radiation Devices (PRDs) and plan to distribute them during upcoming training classes.



### **Cybersecurity Update**

Cyber and ransomware incidents are occurring more frequently and have the potential to cause widespread damage. Malicious cyber actors — including nation-

states and cyber criminals — are growing more sophisticated and difficult to detect. These actors exploit vulnerabilities in information technology systems and infrastructure to steal data, disrupt essential services, and obtain ransom money.

Given the increasing severity and frequency of these attacks, organizations must be prepared to act swiftly and effectively. The Bay Area UASI seeks to provide entities across the region with the tools and support they need to strengthen cybersecurity planning and enhance resilience.

The UASI works closely with the Northern California Regional Intelligence Center (NCRIC) and encourages Bay Area partners to report cyber incidents via: <u>https://ncric.ca.gov</u>. The NCRIC tracks these incidents and can work with organizations to mitigate or recover from a cyber incident. Any victim information submitted to the NCRIC is anonymized to name only the affected critical infrastructure sector (water, healthcare, IT, emergency services, education etc.).

Resources Available to the region include: the <u>Bay Area UASI COOP Toolkik</u>, the <u>Bay</u> <u>Area UASI Cyber Incident Response Plan</u> <u>template</u> and the <u>Bay Area Regional Cyber</u> <u>Incident Response Framework</u> which assists organizations/jurisdictions in strengthening cyber incident response capabilities.

# Compliance Corner & Management Team

## Compliance Corner:

Over the last several years, many agencies have requested UAS (unmanned aircraft systems, commonly referred to as drones) to either develop or continue expanding their programs. This process has proven to be quite time consuming and challenging. The process is so lengthy that agencies have sometimes been unable to obtain approval before the end of the grant performance period. Prior preparation will be the key to successfully receiving approval within the grant performance period. Other than advising you to start early, here are some tips for successfully obtaining approval for your project:



Develop policies and procedures that meet the requirements of the 2015 Presidential Memorandum titled Promoting Economic Competitiveness While Safeguarding Privacy, Civil Rights, and Civil Liberties, in Domestic Use of Unmanned Aircraft Systems. Some of the highlights include: the frequent review of these policies, the collection, use, retention, and dissemination of information obtained by the UAS, the protection of Civil Rights and Civil Liberties, procedures to address accountability concerns and complaints, and oversight of individuals who have access to sensitive information. Please review this memorandum and use it to develop or revise your own policies.

Complete and submit the Aviation Request Form. The standard Aviation form used by CalOES is still used for the purchase of drones, but also requires more detailed responses, including: a more complete description of the purchase (including the manufacturer's country of origin, how you determined cost reasonableness, the number of neighboring jurisdictions with similar, sharable capabilities, the need for the UAS and how it best meets the need as compared to other options, how this equipment fits into the Urban Area's integrated operation plans, other terrorism prevention and incident response equipment that will be included, and lastly certification of the review and understanding of the DHS Cybersecurity and Infrastructure Security Agency (CSIA), Unmanned Aircraft Systems (UAS) Fact Sheets (https://www.dhs.gov/publication/uas-factsheets) and Chinese Manufactured Unmanned Aircraft Systems Industry Alerts.
