3. REVIEW OF FY14 UASI PROPOSAL IMPLEMENTATION GUIDANCE (Discussion)

Presentation by Assistant General Manager, Catherine Spaulding on the breakdown of the proposal submission criteria and process. Online forms will be available 10/15/13 – 11/15/13 for proposal submissions. Subject Matter Experts (SMEs) and work groups will be implemented according to Hub or Advisory Group Members. Role of the four Hubs: Approval Authority Members appoint Hub Members, meetings will be coordinated by the Management Team, meetings will take place in January 2014 with a given planning amount based on the previous year's allocation. Role of the Advisory Group: sustainment projects

will have a prioritized list according to funding allocation for final decisions of the Approval Authority. Allocation of Funding: projects will be vetted and selections/recommendations will be presented to the Approval Authority in advance of receiving the grant award in early 2014. Priority Capability Objectives: list of priority capability objectives and proposals will have to fit in the core capabilities to be considered eligible. Review of timeline from now through March 2014, with the final approval of projects by the Approval Authority.
